You may enter a plea of “GUILTY”, NOLO CONTENDERE” (i.e. no contest) or “NOT GUILTY” to the charges listed on your citation. Your plea may be made by your PERSONAL ATTENDANCE in the Justice Court or the personal attendance of an attorney appearing in the Justice Court on your behalf. ONLY in the event that you wish to plea “GUILTY” or “NOLO CONTENDERE”, you may mail to the Court your plea along with a “waiver of jury trial”.

This chart is a “*guideline*” of what the Court may consider your fine to be in the event that you do not wish to personally appear in Court, and chose to mail a plea of “*Guilty*” or “*Nolo Contendere*” along with a “*Waiver of Jury Trial*”. You must call the court in person at the phone number listed in order to receive the exact fine amount.
