2. If you wish to enter a plea of Not Guilty and desire a trial, indicate in the proper space provided below.
3. If you fail to respond to the charge(s) by the appearance date shown on the citation, an additional charge will be filed against you for Violate Promise to Appear, warrants will be issued for your arrest and you may be Denied Renewal of your Driver's License through DPS/ Omni or Non-Resident Violator Compact (NRVC).
