ALLOW CHILD UNDER 17 YEARS OF AGE TO RIDE UNSECURED	\$250.00
ALLOW CHILD AGE 0 - 8 RIDE UNSECURED BY SAFETY BELT	\$250.00
DEFECTIVE EQUIPMENT – HEADLIGHT – TAILLAMP	\$250.00
USE OF EQUIPMENT NOT APPROVED/WINDOW TINT	\$250.00

****A EXPIRED REGISTRATION MAY BE DISMISSED UPON PROOF OF VALID REGISTRATION AND A COPY OF THE REGISTRATION RECEIPT SHOWING THAT A PENALTY (late fee) WAS PAID**

FOR ANY CHARGE NOT LISTED ABOVE - CONTACT THE PROPER COURT.

ALLOW CHILD UNDER 17 YEARS OF AGE TO RIDE UNSECURED	\$250.00
ALLOW CHILD AGE 0 - 8 RIDE UNSECURED BY SAFETY BELT	\$250.00
DEFECTIVE EQUIPMENT – HEADLIGHT – TAILLAMP	\$250.00
USE OF EQUIPMENT NOT APPROVED/WINDOW TINT	\$250.00
